4. First Aid Measures

Ingestion: If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

Skin Contact: If any component of this contacts the skin, flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.

Inhalation: If any component of this kit is inhaled, remove to fresh air. If breathing becomes difficult give oxygen. If breathing stops, administer artificial respiration. Call a physician.

Eye Contact: If any component of this contacts the eyes, flush with copious amounts of water for at least 15 minutes. Check for and remove contact lenses. Assure adequate flushing by separating the eyelids. Get immediate medical attention.

5. Fire and Explosion Hazard Data

6. Fire and Explosion Hazard Data

Personal precautions: No action shall be taken involving any personal risk or without suitable training. Evacuate surrounding areas. Keep unnecessary and unprotected personnel from entering. Do not touch or walk through spilled material. Provide adequate ventilation.

Wear appropriate respirator when ventilation is inadequate. Put on appropriate personal protective equipment (see section 8).

Environmental precautions: Avoid dispersal of spilled material and runoff and contact with soil, waterways, drains and sewers. Inform the relevant authorities if the product has caused environmental pollution (sewers, waterways, soil or air).

Large spill: Move containers from spill area. Approach release from upwind. Prevent entry into sewers, water courses, basements or confined areas. Vacuum or sweep up material

and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor. Note: see section 1 for emergency contact information and section 13 for waste disposal.

Small spill: Move containers from spill area. Vacuum or sweep up material and place in a designated, labeled waste container. Dispose of via a licensed waste disposal contractor.

7. Handling and Storage Exposure controls/personal protection

This kit should be stored as recommended on the product label. All components should be kept in tightly closed containers. Refer to the storage section of the kit insert for future information. This kit should only be handled and used by qualified, trained professionals.

8. Exposure controls/personal protection

Recommended monitoring procedures: If this product contains ingredients with exposure limits, personal, workplace atmosphere or biological monitoring may be required to determine the effectiveness of the ventilation or other control measures and/or the necessity to use respiratory protective equipment.

Engineering measures: No special ventilation requirements. Good general ventilation should be sufficient to control worker exposure to airborne contaminants. If this product contains ingredients with exposure limits, use process enclosures, local exhaust ventilation or other engineering controls to keep worker exposure below any recommended or statutory limits.

Hygiene measures: Wash hands, forearms and face thoroughly after handling chemical products, before eating, smoking and using the lavatory and at the end of the working period.
