4. First Aid Measures

Ingestion: If any component of this kit is swallowed, wash out mouth with water provided person is conscious. Call a physician or poison control.

Skin Contact: If any component of these contacts the skin, flush with copious amounts of water and wash with soap and water for at least 15 minutes. Remove contaminated clothing and shoes. Call a physician if irritation or discomfort develops.

Inhalation: If any component of this kit is inhaled, remove to fresh air. If breathing becomes difficult give oxygen. If breathing stops, administer artificial respiration. Call a physician.

Eye Contact: If any component of these contacts the eyes, flush with copious amounts of water for at least 15 minutes. Check for and remove contact lenses. Assure adequate flushing by separating the eyelids. Get immediate medical attention.

8. Exposure controls/personal protection
